The Dates of the Festival are May 23-26, 2018. The hours will be May 23, 24, 25: 6-11pm and Saturday, May 26: NOON-11pm. On Wendesday, May 23, the festival will open at 2:00 p.m. for senior citizens only.

BOOTHS: 12'X12', space will be allocated on a first come, first serve basis. All vendors must provide their own table, tent and display structures. Booths must be setup by 5pm Wednesday, Thursday and Friday. Booths must be setup by 11am on Saturday.

ELECTRIC: 110/15 is available at no charge. 220 volt is available for an additional fee.

FEES: \$75.00 for all 4 days. \$100 for food trucks and food vendors. Fee must be paid before setup begins. No early tear downs. You are expected to participate in the entire day's festivities. Non-profit organizations will receive discounted rates.

VEHICLES: Vehicles must be removed from the area by the opening of the day's festivities. Due to liability issues, no loading or unloading will be allowed during festival hours – **NO EXCEPTIONS**.

CLEANUP: You are responsible for cleaning the area around your booth during the entire event. At the end of the Festival, all refuse must be removed. Dumpsters will be provided for trash disposal.

ANIMALS/PETS: Absolutely no animals except guide animals are permitted on Festival grounds.
