APPLICATION FOR CONCESSION STANDS, CRAFT BOOTHS & DISPLAYS

Thank you for your interest in the Annual Blossburg State Coal Festival. We look forward to your participation.

The Dates of the Festival are May 21-23, 2020. The hours will be Thursday & Friday, May 21 & 22: 6pm to 10pm and Saturday, May 23: NOON to 10pm.

BOOTHS: A 12'X12' space will be allocated on a first come, first serve basis. **All vendors must provide their own table, tent and display structures.** Booths must be setup by 5pm, Thursday and Friday. Booths must be setup by 10am on Saturday. **All booths/canopies/tables must be anchored.**

VEHICLES: Vehicles must be removed from the area by the opening of the day's festivities. Due to liability issues, no loading or unloading will be allowed during festival hours – **NO EXCEPTIONS.**

ELECTRIC: Is available for a \$25 fee.

FEES: \$75.00 for all 4 days. \$100 for food trucks and food vendors. **Fee must be paid before setup begins.** No early tear downs. You are expected to participate in the entire day's festivities. Non-profit organizations will receive discounted rates.

CLEANUP: You are responsible for cleaning the area around your booth during the entire event. At the end of the Festival, all refuse must be removed. Dumpsters will be provided for trash disposal.

***All Vendors are responsible for emptying the garbage nearest their booth, daily.** All Food Vendors are required to add a \$50 refundable garbage disposal fee and all other vendors are required to add a \$25 refundable garbage disposal fee to their vendor fees.

ANIMALS/PETS: Absolutely no animals except guide or service animals are permitted on Festival grounds. Proper paperwork designating animal as a guide or service animal must be readily available upon entering the festival and if asked.

By participating in the Blossburg State Coal Festival, you agree to abide by the rules set forth by the Coal Festival Committee. The Coal Festival Committee reserves the right to reject **any** vendor application or contract.

All booths, displays, stands, etc. held in conjunction with the Blossburg State Coal Festival must be approved in advance by the Coal Festival Committee. **Every individual, business, or organization planning to participate in the Blossburg State Coal Festival must complete application.** The committee reserves the right to remove any item(s) from the Festival grounds.
